Dear Sir,

In inviting a reference to SECI, New Delhi RfS No. SECI//C&P/MI/00/0010/2022-23 dated: 31/12/2022 communicated by MNRE, GoI with all Amendments, Tripura Renewable Energy Development Agency (TREDA) is pleased to issue the Letter of Award for above mentioned assignment as per the scope of work, special terms & conditions mentioned hereunder.

1. A list of prospective beneficiaries will be issued to empanelled firm separately for site survey, verification and to obtain consent from beneficiary farmer. TREDA will verify the survey report and will issue Notice to Proceed (NTP) to the empanelled firm and confirmatory order for installation of Solar Photovoltaic Water Pumping Systems (SPWPS).
2. The details of empanelment against you for various types and categories of pumps with Base Rates (including GST) for Solar Photovoltaic Water Pumping System with normal Pump Controller:

**3. CONTRACT, SCOPE, METHODOLOGY, SCHEDULE & RESPONSIBILITY OF WORK:**

- a) The broad scope of work shall include to Design, Manufacture, Supply, Transport, Installation, Testing and Commissioning of Off-Grid Solar Photovoltaic water pumping systems (SPWPS) of 1-10 HP (in selected States on PAN India basis, including complete system warranty & its repair and maintenance for 5 years under Component-B of PM-KUSUM scheme of MNRE: as per MNRE specifications and applicable BIS standards for implementation after aggregating demand from TREDA.
  - b) Detail scope of work mentioned at SECTION-2 "TECHNICAL & SPECIAL CONDITIONS OF CONTRACT" of above referred RfS Document shall be complied with.
4. Within 30 (thirty) days from the date of issuance of Letter of Award, you have to submit Valid Test Report of Complete Solar Pumping system and drawing & design of civil foundation & MMS to TREDA in compliance with the guideline for PM-KUSUM – Component B, RfS document, MNRE specification, testing procedures issued in 2019 by MNRE from NISE and any other lab accredited

by NABL for the particular Pump Model, which are quoted (SPWPS) in the tender issued by SECI in favour of TREDA.

5. Within 30 (thirty) days from the date of issuance of Letter of Award, you have to submit BIS/IEC Certificate of PV Module, Pump, Controller etc. (As per PM- KUSUM Guideline – Component B and MNRE specification & testing procedures issued in 2019).
6. You have to submit signed copy of Formats-7.12, 7.13, 7.14 of RfS document during signing of Agreement.
7. Within 15 (fifteen) days from the date of issue of the Letter of Award, you have to submit Performance Bank Guarantee (PBG) @ 3% of the amount equivalent to the 6% of the value of total state-wise allocation or 25 numbers of SPWPS, whichever is higher (as per Annexure-E). However, if total number of SPWPS awarded to vendor is more than 25 nos. of SPWPS or 6% of the value of total state –wise allocation. Along with the first list of consent from beneficiaries in vendor's favor, vendor shall submit another PBG equivalent to differential value of order as per notice to proceed (NTP). It may be noted that Successful Bidders shall submit the PBG according to the Format 7.3 C with a validity period up to (& including) the date as on 24 months from placement of award by TREDA. Validity of PBG shall be extended by the vendor for every year for the first five year. Further TREDA reserves the right to encash the existing PBG, in case the vendor doesn't renew/extend the existing PBG at –least 30 days in advance. PBG should be in favour of Director General, Tripura Renewable Energy Development Agency (TREDA), Vigyan Bhawan, Gorkhabasti, Agartala, Tripura Pin: 799006, from any of the Scheduled Commercial Banks as listed by RBI as per RfS document.
8. Considering the state allocation of Tripura you have to submit PBG in the tune of Rs.14, 41,800/- Only.
9. Notice to Proceed (NTP) will be issued on receipt of PBG in staggered manner after finalization of beneficiary farmers through site survey conducted by you and beneficiary contribution received in the account of TREDA thereof. The amount of actual Contract Performance Guarantee (PBG) will be mentioned in the NTP. The differential value if any in the amount of PBG as per NTP shall have to submit separately.
10. Purchase Preference as per 'Public Procurement (Preference to Make in India), Order 2017' (Latest Amendment Dated: 16th September-2020) should be maintain.
11. Terms of Payment & Process for raising Invoice/Bill: As mentioned at RfS Document.
12. Un-priced invoice from Vendor/sub vendors has to be provided as a proof of indigenous component/accessories having supplied for solar pump & PV module etc.
13. The Carbon Credit of the Project will be the sole authority of TREDA and in no any such claim of the firms/beneficiary farmers will be entertained.
14. The specifications, terms & conditions shall be guided by the RfS No. SECI//C&P/MI/00/0010/2022-23 dated: 31/12/2022 with all Amendments issued by SECI in favour of TREDA.
15. In failure of submitting documents within the time limit as per terms & conditions of the tender issued by SECI in favour of TREDA, empanelment will be cancelled without any prior intimation.
16. The final authority to decide any matter, either on reference or suo-moto will be by Director General, TREDA.
17. Tentative quantity of pump to be installed are 1000 number, however the number may increase or decrease depending upon the performance.

You are requested to accept the Letter of Award (LoA) & submit the signed copy of LoA within 7 (seven) days from the date of issue of this LoA, otherwise, it will be presumed that you have accepted the LoA unconditionally.

You are also requested to enter into an Agreement with TREDA in Non-judicial Stamp Paper of Rs.100/- only for strict compliance of terms & conditions of the RfS issued by SECI in favour of TREDA. The Agreement shall contain Contract Agreement at top and then Letter of Acceptance, Letter of Award, techno-commercial offer, copy of Price Bid & copy of all tender documents are to be placed. The Agreement shall be signed within 10 (ten) days from the date of issuance of Letter of Award.


