#### 4. SCOPE OF WORK:

- a. The broad scope of work shall include to Design, Manufacture, Supply, Transport, Installation, Testing and Commissioning of 1300 numbers of Off-Grid Solar Photovoltaic water pumping systems (in selected Districts to beneficiary farmers) including complete system warranty & its repair and maintenance for 5 years under MNRE offgrid and decentralized solar PV applications scheme: as per MNRE specifications and applicable BIS standards for implementation after aggregating demand from TREDA.
- b. The detail scope of work is mentioned at ANNEXURE-1 under SECTION-4 "TECHNICAL & SPECIAL CONDITIONS OF CONTRACT".
- You are requested to enter into an Agreement with TREDA in Non-judicial Stamp Paper of Rs.100/- as per terms & conditions of the tender issued by EESL in favour of TREDA. The Agreement shall contain the signed copy of bid document along with Amendment / Corrigendum, offer of bidder etc.
  - A. You are requested to submit Valid Test Report of Pumps to TREDA in compliance with the guideline for PM-KUSUM Component B, MNRE specification, testing procedures issued in 2019 by MNRE from NISE and any other lab accredited by NABL for the particular Pump Model, which are quoted (SPWPS & USPC) in the tender issued by EESL in favour of TREDA.
  - B. You are also requested to submit BIS/IEC Certificate of PV Module, Controller, and USPC etc. (As per PM- KUSUM Guideline Component B and MNRE specification & testing procedures issued in 2019).

- 2. Also Submit Contract Performance Guarantee (CPG) in favour of Director General & Chief Executive Officer, Tripura Renewable Energy Development Agency, Vigyan Bhawan, Gorkhabasti, Agartala, Tripura as per Clause No. L under SECTION-4 of the tender issued by EESL in favour of TREDA. The amount of BG will be intimated while issuing staggered Notice to Proceed (NTP) after finalization of beneficiary farmers.
- 3. Un-priced invoice from sub vendors has to be provided as a proof of indigenous component/accessories having supplied for solar pump & PV module etc.

- 7. The Carbon Credit of the Project will be the sole authority of TREDA and in no any such claim of the firms/beneficiary farmers will be entertained.
- 8. The other terms & conditions shall be guided by the tender issued by EESL in favour of TREDA.

- 9. In failure of submitting documents within the time limit as per terms & conditions of the tender issued by EESL in favour of TREDA, empanelment will stand cancelled without any prior intimation.
- 10. The final authority to decide any matter, either on reference or suo-moto will be Director General, TREDA.
