You are now requested to submit Performance Bank Guarantee (PBG) equivalent to 3 % of contract price (Rs. **13,44,058.00**) as per RfS issued by SECI with the validity period up to (& including) the date as on 24 months from the placement of award. The validity of PBG shall be extended by the vendor for every year for the first five year. Further, TREDA reserves the right to encash the existing PBG, in case the vendor doesn't renew/extend the existing PBG at-least 30 days in advance. PBG shall be in the shape of Bank Guarantee (Format-7.3 C) from any Nationalized Bank/other scheduled private banks as per RfS document. The PBG shall be submitted within 10 days of issuance of NTP. The NTP along with PBG will be a part of Agreement.

You are also requested to start manufacturing process of all components of solar pumps as indicated in the NTP and dispatch the materials on receipt of inspection clearance from TREDA.
